Sir,

It has reference to your proposal regarding granting extension of provisional affiliation for the session 2019-20 to your institute for B.Sc. Nursing Course.

On the basis of the report of the Inspection team (which visited your institute on 12.10.2019) and as per recommendation of various statutory bodies of the university, your institute is granted the extension of provisional affiliation (for one year) for the academic session 2019-20 for B.Sc. Nursing with 60 seats to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

1. The extension of provisional affiliation is presently for one year only for the academic session 2019-20.
2. The extension of provisional affiliation is based upon the extension of recognition accorded to your institute by BNRC letter no.1883 dated 09.09.2019.
3. This extension of provisional affiliation is granted for B.Sc. Nursing Course with an upper limit of intake of 60 students.
4. This extension of provisional affiliation is subjected to attending all the deficiencies pointed out by the Inspection team (report enclosed). The university should be informed through affidavit about the removal of all the deficiencies within a period of 60 days from the date of issue of this letter.
5. On receipt of the affidavit, the University may inspect your college at any working day without information.
6. All minutes of Governing Body should be submitted to the office of Aryabhatta Knowledge University, Patna at the earliest.
