DIRECTIVES ON ANTI-RAGGING

The Directives on Anti-Ragging in "D.P. Singh Institute of Education " are hereby being framed under the guidelines of University Grants Commission, New Delhi,

The following acts have been defined as "Ragging":

1. Any conduct by any student or students whether by words spoken or written or by rowdy or indisciplined act which has the effect of teasing, treating or handling with rudeness, or which cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in a fresher or any other student.
2. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student
3. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher, or by exploiting the services of a fresher or any other student for completing academic tasks allocated to an individual or group of students.
4. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
5. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student
6. Any act or abuse by spoken words, emails, post, public insults which causes discomfiture to fresher or any other student.
7. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
8. Any indulgence of above acts by trespassers against any student of the college is liable to be punished under the laws of the land.

MEASURES UNDERTAKEN BY, "D.P. Singh Institute of Education" TO ENFORCE ANTI-RAGGING REGULATIONS

1. The college has a functional Anti-Ragging Cell as well as an Anti-Ragging Squad consisting of the Principal as its Chairman; a Teacher Coordinator, Teacher Members; student representatives.
2. Each Department, canteen and other significant places in the college have notices bearing the slogans "Ragging is banned" and "Ragging is a punishable offence".
3. Any student /students who become victim/s of ragging has full right to lodge a complaint immediately with the Anti-Ragging Cell for proceedings to be initiated within the next 2 hours.
4. Complaints of ragging at "D.P. Singh Institute of Education" can be lodged online.
5. In case the victim student does not wish his/her identity to be known to the general public, then the victim may drop a written complaint in the Complaint Box located in the Administrative Block.
