Sir,

It has reference to your proposal regarding granting fresh affiliation to your institute for above mentioned 01 (one) subject.

On the basis of the report of the Inspection Team (which visited your proposed institute on 12-12-2018) and as per recommendation of various statutory bodies of the university, your institute is granted provisional affiliation to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

1. The provisional affiliation is presently for one year only for the academic session 2018-19.
2. The provisional affiliation is based upon the approval accorded to your proposed institute by the Bihar Nurses Registration Council, Patna vide letter no. 1634/बी.एन.आर.सी. dated 28-11-2018.
3. The provisional affiliation is granted for 01 (one) course B. Sc. (Nursing) and with an upper limit of intake of 60 (sixty) students. You are also directed to take admission till 31st December, 2018 as per Indian Nursing Council direction.
4. This affiliation is subject to the condition of deposit of endowment fee of Rs.5,00,000/- (Five Lakh) in any Nationalised/scheduled bank branch as Fixed Deposit in the name of College and the said FD will be pledged in favour of the Registrar, Aryabhatta Knowledge University, Patna. A Xerox copy of the FD duly attested by the Principal of the College will be send to the University by means of a letter within a week from the date of receipt of this letter, failing which this letter will be automatically treated as withdrawn.
5. Affiliation fees of Rs.75,000/- (Seventy-five thousand) per unit in favour of Aryabhatta Knowledge University - Affiliation Fund payable at Patna, which must be deposited before receipt of this letter, failing which this letter will be automatically treated as withdrawn.

This affiliation is subjected to attending all the deficiencies/remarks pointed out by the INC & Inspection team (which visited on 07-12-2018- copy of report enclosed) and to inform the university through affidavit about the removal of all the deficiencies and fulfilment of other conditions as pointed out in INC letter & the inspection report under reference within a period of six months.
7. The University may inspect your college at any working day without information to check the infrastructure as well as the academic activity of your college as per guidelines of INC/GoB/AKU.
8. All minutes of Governing Body should be submitted to the office of Aryabhata Knowledge University, Patna at the earliest.
9. When any vacant post will be filled by the college/institute, University representative should be invited. Any appointments must be done either in presence of University representative or State Government nominee.
10. Provisional affiliation has been granted in anticipation of approval of Court, Aryabhata Knowledge University, Patna.
11. Rules/regulations, etc. regarding syllabus and conduct of examination etc. shall be communicated after all the conditions for provisional affiliations are met with by your institute to the full satisfaction of the University.
12. Failing the above terms and conditions, this letter will be automatically treated as withdrawn. In such case no further correspondence shall be entertained.
